## PERMISSION & AGREEMENT

- I hereby give my child(ren) permission to attend Camp Livingston and participate in all activities.
- I agree that my child's acceptance into Camp is not official until written confirmation is received from the Camp office.
- I understand that \$250 per session is a non-refundable deposit.
- I understand that if I cancel my application before April 30, 2010, all of my money, except the \$250 deposit per session, will be refunded. If I cancel between May 1, 2010 and May 31, 2010, I will still be responsible for 50% of the total camp fees. Cancellations received after June 1, 2010 will still be responsible for 100% of camp fees.

- I understand that I am ultimately responsible for paying the camp tuition. I further understand that full payment of tuition is due by May 15, 2010 and that my child's registration may be voided if approved payment arrangements have not been made with the Camp Livingston office by May 1, 2010.
- I understand that Camp Livingston scholarship applications must be postmarked by January 31, 2010. Scholarship applications received after that date may not be honored as there may not be funds available after this date.
- I understand that Camp Livingston staff does not accept tips or gratuities. Our staff understands this and agrees to adhere to it in their signed contracts. Donations in honor of staff members are welcomed to the Camp Scholarship Fund.
- I agree that Camp Livingston may share my family's contact information with other camp families for communication purposes only, unless I indicate otherwise in writing.
- I agree that Camp Livingston has my permission to use photographs, video or likenesses of my child for promotional purposes, unless I indicate otherwise in writing.
- I hereby agree to hold Camp Livingston harmless from any liability except for those camp-sponsored activities.
- It is agreed that any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, can only be brought in the Hamilton County Court of Common Pleas located in the County of Hamilton, Ohio, and shall be construed in accordance with the laws of Ohio.
- I understand that part of the camping experience involves activities and group interactions that may be new to my child, and that they come with uncertainties beyond what my child may be used to dealing with at home. I am also aware that my child may participate in off-campus activities such as recreational field trips to local amusements or camping trips that involve additional risks. I am aware of these risks and I am assuming them on behalf of my child. I realize that no environment is risk-free and so I have instructed my child on the importance of abiding by the camp's rules. My child and I both agree that he or she is familiar with these rules and will obey them.
- I understand that Camp Livingston does not accept responsibility for loss, theft or damage to the clothing, equipment, or personal effects of campers during the session or while in transit. Cellular phones, laptop computers, and other wireless communication devices are not permitted in camp. Items such as these that arrive with campers will be held for safe keeping in the camp office until the completion of the camper's session.
- As a parent, I am ultimately responsible for all transportation of my child and his/her belongings to and from camp.
- I understand and will comply with the following: Campers are expected to arrive and depart on the opening and closing days of their sessions and to remain in camp for the entire time. Having campers leave during a session is very disruptive to both the camper and the camp community. Consequently, requests for exception must be submitted in writing and approved by the Camp Director prior to the start of the camper's session.
- I represent to Camp Livingston that I will make full disclosure of any and all medical, emotional, or social conditions and medications (including medication holidays) that may affect my child's experience at camp.
- I understand that if my child is sent home for any reason or if I withdraw my child for any reason during the camp season I am not entitled to a refund.
- I understand that the Camp Director reserves the right to dismiss any camper without refund who:
  - a) Willfully disregards camp rules, or who endangers the camper's or others' safety;
  - b) Harms him/herself or other members of the community;
  - c) Bullies, physically, psychologically, and/or sexually abuses any member of our community;
  - d) Destroys camp property or the property of another member of the camp community;
  - e) Requires greater supervision than can reasonably be offered by the camp;
  - f) Does not follow the Camp Livingston Camper Behavior Contract;
  - g) Acts in any way which the Camp Director, in his sole discretion, finds to be detrimental to the camp community.
