

# Minor Participant Waiver

## **PLEASE READ CAREFULLY.**

**I, in my legal capacity as the parent/guardian of the minor named below (“Minor”), do hereby acknowledge, understand and agree on behalf of both myself and the Minor that:**

(a) any use of Mayerson JCC (“JCC”), Cincinnati Jewish Teen Collective (“CJTC”) and/or Camp Livingston facilities, services, equipment and premises (collectively “Facilities”) and any participation in or activities of the Early Childhood School, Camp at the J, Club J, J Play, CJTC or Camp Livingston (collectively “Programs”) comes with inherent risks including, but not limited to, illness, disease and other ramifications which may result due to exposure to and/or infection with viruses or bacteria such as the coronavirus/COVID-19, for myself and Minor,

(b) the foregoing list is not inclusive of all possible coronavirus/COVID-19 risks associated with Facilities and Programs it in no way limits the operation of this agreement,

(c) I accept and assume, for myself and the Minor, full responsibility for these risks and I am not relying on all such risks to be described in this document,

(d) I will fully and accurately complete all Camp Livingston, CJTC and/or JCC-required forms and submit Minor to procedures as follows:

(i) on the Minor’s first day at any of the Programs I will bring a this completed Waiver and provide to JCC, CJTC or Camp Livingston personnel at that time,

(ii) any other document(s) that may be required by the JCC, CJTC or Camp Livingston after the date of this agreement, and

(iii) I will permit Minor to have his/her temperature screened before each entry into the JCC, CJTC, Camp Livingston and Programs,

(e) During the Minor’s participation in Programs, I will promptly notify the JCC, CJTC and Camp Livingston if I, the Minor or anyone residing with at least one of us is diagnosed with COVID-19 or has been in close contact with someone who has been diagnosed with COVID-19, and I will not bring the Minor to the JCC, CJTC or Camp Livingston until a health care provider certifies that Minor is not be contagious and may return to the JCC, CJTC Camp Livingston and Programs,

(f) I will not bring Minor to the JCC, CJTC or Camp Livingston at any time Minor is ill, symptomatic or has a fever of 100° Fahrenheit, and I will not return Minor to the JCC, CJTC Camp Livingston or any Programs until he/she is not symptomatic for at least 24 hours without the use of prescription or over the counter medications,

(g) **Coronavirus/COVID-19 is an extremely contagious virus that spreads through person-to-person contact. Federal and state authorities recommend social distancing and other methods as a means to prevent the spread of the virus. COVID-19 can lead to severe illness, personal injury, permanent disability, and death. Attending and/or participating in the Programs could increase the risk of exposure and contracting COVID-19. Neither the JCC, CJTC nor Camp Livingston guarantees, warrants or represents in any way that COVID-19/Coronavirus infection will not occur through Minor’s participation in the Programs or by use of Camp Livingston, CJTC or JCC Facilities.**

(h) **In consideration of Minor’s use of or access to Facilities and participation in Programs I, on behalf of myself and Minor and our respective heirs, representatives, executors, administrators, and assigns (“Releasers”), DO HEREBY AGREE TO FOREVER RELEASE, WAIVE, INDEMNIFY, DEFEND AND HOLD HARMLESS the JCC, CJTC Camp Livingston and their respective officers, directors, agents, employees, volunteers, insurers and representatives (“Releasees”) from any causes of action, claims or demands of any kind or nature whatsoever including, but in no way limited to, claims of negligence, which I, the Minor and/or all Releasers may have now or in the future against the Releasees (individually or jointly) on account of or relating to personal injury, property damage, disability, death, accident, viral/fungal/bacterial infection, sickness or disease incurred by Minor, however occurring with respect to or from participation in Programs and/or use or access to Facilities. I understand that Minor and I will be solely responsible for any loss or damage for, including but not limited to, personal injury, property damage, disability, death, accident, infection of any kind or nature, sickness or death sustained from the use of or access to Facilities and participation in Programs.**

(i) I and/or Minor may be photographed, recorded and videotaped by JCC, CJTC and Camp Livingston and their agents and representatives (“Photographers”) in connection with participation in Programs, and I hereby irrevocably authorize Photographers and their respective affiliates to copyright, publish, reproduce, exhibit, transmit, broadcast,

televisive, digitize, display, otherwise use, and permit others to use, (a) my and Minor's name, image, likeness, and voice, and (b) all photographs, recordings, videotapes, audiovisual materials, writings, statements, and quotations of or by myself and/or Minor (collectively, the "Materials"), in any manner, form, or format whatsoever now or hereinafter created, including on the Internet, and for any purpose, including, but not limited to, advertising or promotion of Photographers, its affiliates, or their services or Programs, without further consent from or payment to me or Minor. It is understood that all of the Materials, and all films, audiotapes, videotapes, reproductions, media, plates, negatives, photocopies, and electronic and digital copies of the Materials, are the sole property of Photographers. Neither I nor Minor shall contest the rights or authority granted to Photographers hereunder. I understand that Photographers are under no obligation to use the Materials.

(j) **I hereby DO AGREE TO FOREVER RELEASE AND DISCHARGE Photographers and their respective employees, licensees, agents, representatives, successors, and assigns from any claims, actions, damages, liabilities, costs, or demands whatsoever arising by reason of defamation, invasion of privacy, right of publicity, copyright infringement, or any other personal or property rights from or related to any use of the Materials.**

I certify that (1) Minor is in good health and has no conditions or impairments that would preclude their safe participation in Programs or use of Facilities and (2) I have the legal capacity to act as the parent/guardian of the Minor. I understand this document is legally binding.
